Registering on our website

We collect some personal details, such as your name, address, contact details, telephone number and e-mail address when you register to use our customised services. If you have registered with us you will be able to access content and services which are only offered to registered users. Registered users also have the option to amend or delete at any time the details supplied on registering. Naturally we will provide you with information about which of your personal details we hold at any time. Unless contrary to statutory duties of retention we will also be happy to correct or delete this information on request. Please use the contact details at the end of this Data Protection Statement to contact us about this.

We use a state-of-the-art encryption system (e.g. SSL), via HTTPS, to ensure your data's security during transmission.

Newsletter

When you subscribe to our newsletter the details you provide will be used exclusively for this purpose. Subscribers may also be notified of facts relating to the service or their subscriptions (such as changes to the newsletter service or technical specifications) by e-mail.

We require an active e-mail address for a valid subscription. We use the "double opt-in" procedure to check that the subscription has actually been taken out by the owner of the e-mail address. To do this we check the subscription to the newsletter, dispatch of a confirmation e-mail and receipt of the reply requested in the confirmation e-mail. We do not collect any other data. The data is used exclusively for dispatching the newsletter and is not passed to third parties.

You can withdraw your consent to storage of your personal details and their use for dispatch of the newsletter at any time. Every newsletter contains a link for this purpose. You can also unsubscribe direct on this website at any time or inform us of your wishes by using the contact option at the end of this document.

Contact form

If you contact us by e-mail or using the contact form, the information you provide will be stored in order to process your enquiry and for potential follow-up issues.

Google AdWords

Our website uses Google conversion tracking. If you reached our website via an advertisement placed by Google, Google AdWords will place a cookie on your computer. The conversion tracking cookie is installed when a user clicks on an advertisement placed by Google. These cookies expire after 30 days and are not used for personal identification. If the user visits certain pages on our website and the cookie has not yet expired, we and Google can identify that the user has clicked on the ad and was directed here. Every Google AdWords customer is given a different cookie. Cookies cannot, therefore, be tracked via the websites of AdWords customers. The information collected using these conversion cookies is used to generate conversion statistics for AdWords customers who have chosen conversion tracking. The customers learn the total number of users who have clicked on their ad and have been forwarded to a page containing a conversion tracking tag. They do not, however, obtain any information which would allow them to identify the user.

If you do not want to participate in tracking you can refuse to have cookies placed on your computer, either by adjusting your browser settings, which deactivates the automatic placing of cookies, or by setting your browser such that it blocks cookies from the "googleleadservices.com" domain.

Please note that you must not delete the opt-out cookies if you do not want data to be recorded. If you have deleted all the cookies in your browser, you will have to set the opt-out cookie again.

Your rights of information, correction, blocking, deletion and objection

You have the right to be provided at any time with information about which personal details we hold about you. You also have the right to correct, block or delete your personal details with the exception of data stored for business processes. Please contact our data protection officers.

Their contact details are at the bottom of this information.

For data blocking to take effect at any time the data must be kept in a blocked file for monitoring purposes. Unless there is a statutory duty to archive the data you can also ask for your data to be deleted. If there is a duty to archive the data we will block your details if you so wish.

You can make changes or withdraw your consent by notifying us with future effect.

Amendment of our data protection provisions

We reserve the right to update this Data Protection Statement from time to time so that it always complies with the current legal requirements or reflects changes to our services, i.e. if we introduce new services.
